- B1. Known Roof Defects The roof was replaced and there is light leakage around the skylight during "Very" heavy rain. We had leakage, into the building, during two flash flood that occurred in the last three years. We contacted PHD Roof Doctor's, Inc., Frank Scarpaci, 340 S Milwaukee St., Fredonia, WI 53021. They cleared out the roof drains that were blocked and patched and sealed an area between the low and high roof abutment. There also was some seepage along the south-west was due to a tree that was overgrowing the building which has been removed.
- B2. Two breakers were replaced in the south side breaker box because due to cooking in the Kiitchen.
- B3. The bathrooms have been snaked out twice because they were slow flushing. It was recommended that we pour 5 gallons of water down about every 90-180 days in both toilets. This has been effective in keeping the toilet flushing without problems.
- B4. The drain for the air conditioner over the showroom will occasionally become plugged up and the drain tray will drip into the showroom. This was cleared out a few months ago and we have had no problems since. The hose needs to be check and cleared ever few years.
- B5. There is no basement.
