*Please allow twelve (12) weeks for glass unit(s) to fully dry after The Glass Guru Moisture Removal System is installed. The System is warranted for 10 years.

SCRATCH & STAIN REMOVAL DISCLAIMER (For all Scratch Removal or Water Stain Removal estimates):

Glass units quoted for scratch and/or stain removal are damaged to the point that the damage cannot be adequately removed with conventional cleaning products or methods.
