AMENDMENT NO. 1 TO DECLARATION OF CONDOMINIUM OF BUSINESS AT RANDOM, A CONDOMINIUM

THIS AMENDMENT NO. 1 TO DECLARATION OF CONDOMINIUM OF BUSINESS AT RANDOM, a CONDOMINIUM (this "Amendment"), is made this 7th day of March, 2024 by BUSINESS AT RANDOM LLC, by John B. Rassel, managing member (the "Declarant") and is made pursuant of the Declaration and the Condominium Ownership Act of the State of Wisconsin, being Chapter 703 of the Wisconsin Statutes (the "Act").

RECITALS

- 1. This Amendment No. 1 to Declaration amends the Declaration as recorded on February 22, 2024 in the Sheboygan County Register of Deeds as Document No. 2160682.
- 2. This Amendment is made pursuant to Article III, Section 3.04 of the Declaration and the Declarant solely has the right to amend the Declaration for expansion of the condominium and further attests that no Units have been transferred or sold.

3. That the legal description of the real estate and the list of Units which are subject to this Amendment is attached as Exhibit A.

AMENDMENTS

NOW THEREFORE, in accordance with the Act, the Declaration, and the foregoing recitals, the Declarant does hereby amend the Declarations as follows:

- 1. Article III, Section 3.01 is hereby deleted in its entirety and replaced with the following Article III, Section 3.01:
 - **3.01. Identification of Units.** The Condominium shall consist of twenty-four (24) units (individually a "Unit" and collectively the "Units") located in the buildings (individually a "Building" and collectively the "Buildings") identified on the Condominium Plat recorded in the Sheboygan County Register of Deeds as Volume 15 of Plats, pages 68-69 as Document No. 2160681 and the First Addendum to Condominium Plat, which is being recorded with the Sheboygan County Register of Deeds contemporaneously and attached hereto as Exhibit B and made a part hereof (collectively known as the "Condominium Plat"), together with the Common Elements as described in Article IV, whether constructed or not yet constructed. The Condominium Plat shows floor plans for each Unit showing the layout, boundaries, and dimensions of each Unit. The Units shall be identified as Units 1 through 24, as numbered on the Condominium Plat. Each owner of a Unit is referred to as a "Unit Owner." When a Unit has been sold under a land contract, the purchaser (and not the vendor) shall be the Unit Owner.
- 2. Article V, Section 5.01 is hereby deleted in its entirety and replaced with the following Article V, Section 5.01:
 - **5.01. Percentage Interests.** The undivided percentage interest in the Common Elements (the "Percentage Interest") appurtenant to each Unit shall be a percentage equal to one divided by the total number of Units. Each Unit's Percentage shall be 4.16%.
- 3. That the changes to the Declaration as reflected by this Amendment are consistent with the Condominium Plat and First Addendum to the Condominium Plat.
